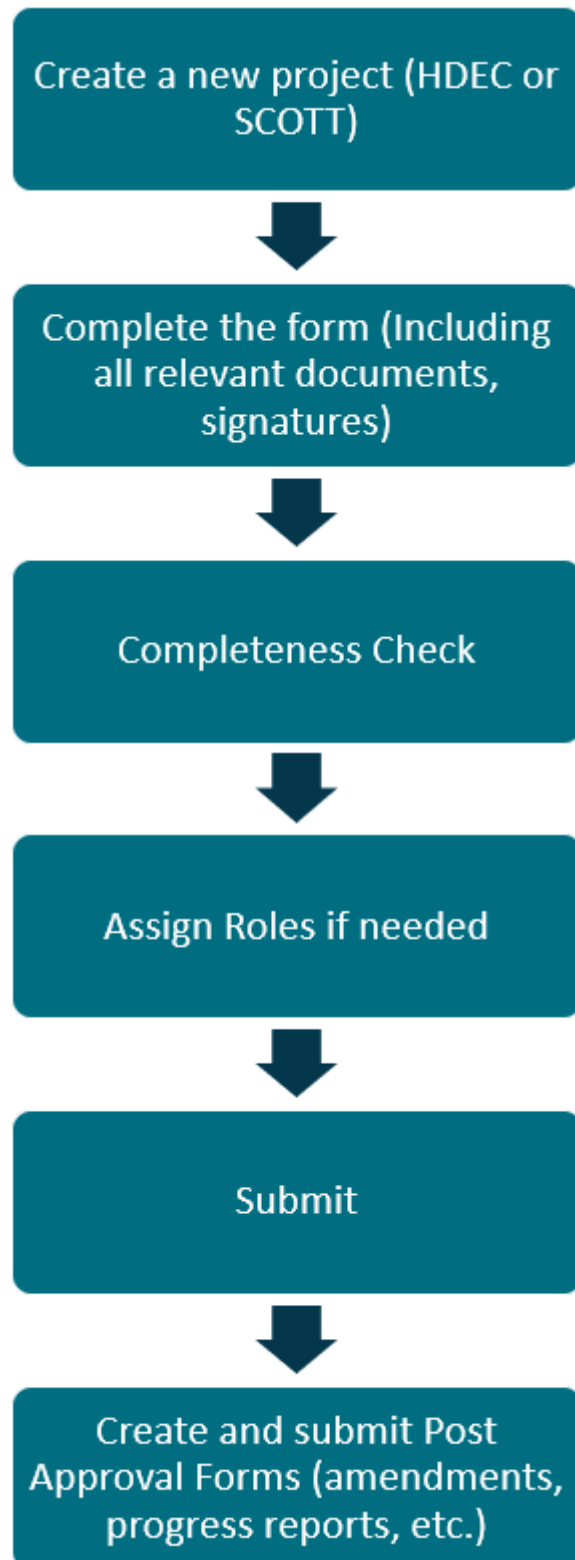

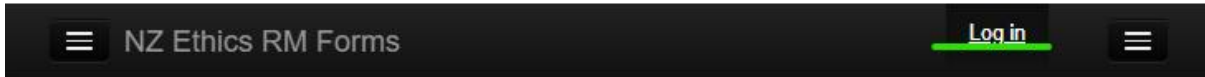
Overview of Ethics Review Manager (Ethics RM) – HDEC or SCOTT applications



1. Create an account in Ethics RM

Ethics RM is a website that enables users to complete and submit applications to the Health and Disability Ethics Committees (HDECs) and the Standing Committee on Therapeutic Trials (SCOTT).

Go to Ethics RM (<https://nz.forms.ethicalreviewmanager.com>)
Click Log in on the top right corner of the page (the Log in button allows you to create an account).

Enter your details, choose a password and click Register after reading and accepting the Terms of Conditions and Privacy Policy. Passwords must be 10+ characters long (but no longer than 64) and must contain both upper and lowercase letters as well as at least one special character and number.

You will receive an activation email to your specified email address. Please check your spam folder if the email does not appear in your inbox.

Click the link to finish activating your account. Your account will not function until this step has been completed.

You may now log in with your email address and password.

If you receive an error message when creating your account, please try logging in with the email and password used to create the account anyway. If this does not work, then please email ethicsrm@health.govt.nz for troubleshooting assistance.

2. Log in to my Ethics RM account, and manage my account details or recover my account

Logging in and out

If you have registered for Ethics RM or have previously had an Online Forms account (Online Forms was the previous online system used by HDECs) then:

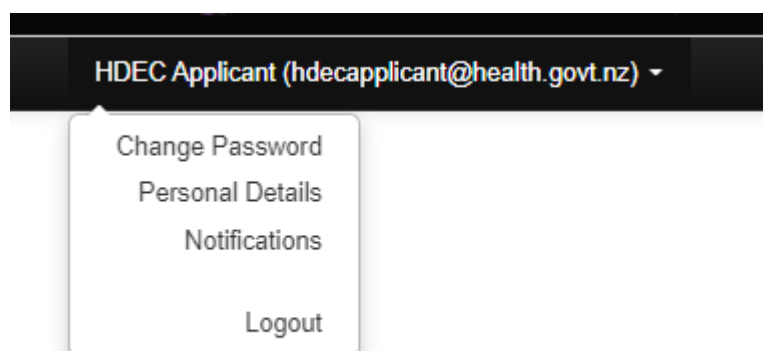
Click Log in on the top right corner of the page.

Enter your email address and password.

Click Log in.

This will automatically bring you to the Work Area, the main screen for Ethics RM. Your name and email address appear at the top right of the screen.

To log out of Ethics RM at any stage, click your name and email address at the top right of the screen and click 'Logout'



Manage account details

Click your name and email address on the top right of the screen.

From there you can select Change Password, Personal Details to view or change your account details, and Notifications as well as Logout.

Notifications brings up information directly related to you and your projects. This information also appears under the Notifications tile of your Work Area.

Account recovery/issues

If you cannot remember your password, please click Forgotten Password when you access the Log in screen. Please enter the email address you use for Ethics RM and click 'Reset Password'.

Follow the instructions sent in your email to reset a new password. This will allow you to log in with your new password.

If you are having further issues with your account, please contact Technical Support (page 48). It is important to note that the Secretariat is unable to help with some account queries. Instead, support for technical issues is managed by [Infonetica](#) and may be escalated to them by the Secretariat.

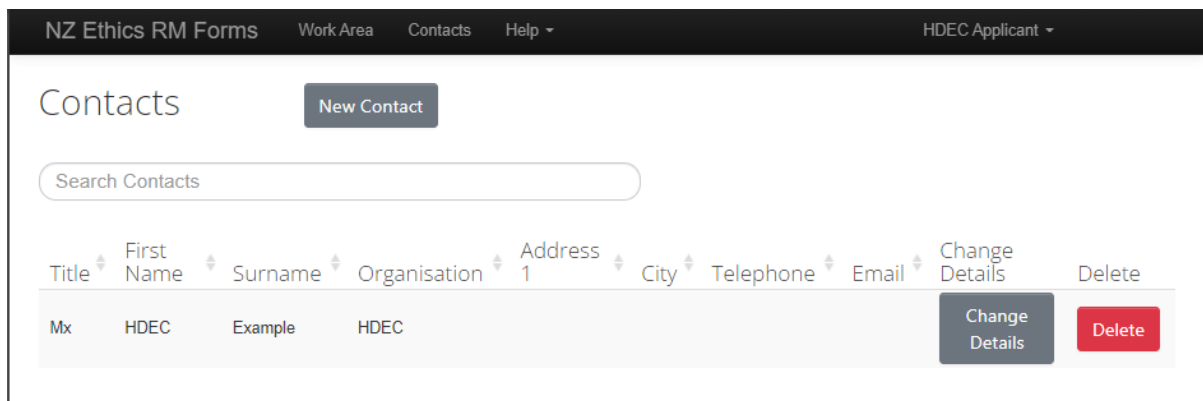
3. Create, Edit or Delete Contacts

Your personal contact database is designed to help you if you are filling out many forms and often refer to a contact multiple times.

To add a contact, click Contacts on the top left of the page:

- click New Contact
- enter their details then click Save.

Existing contacts can be edited by clicking Change Details. Enter or adjust details then click Save.

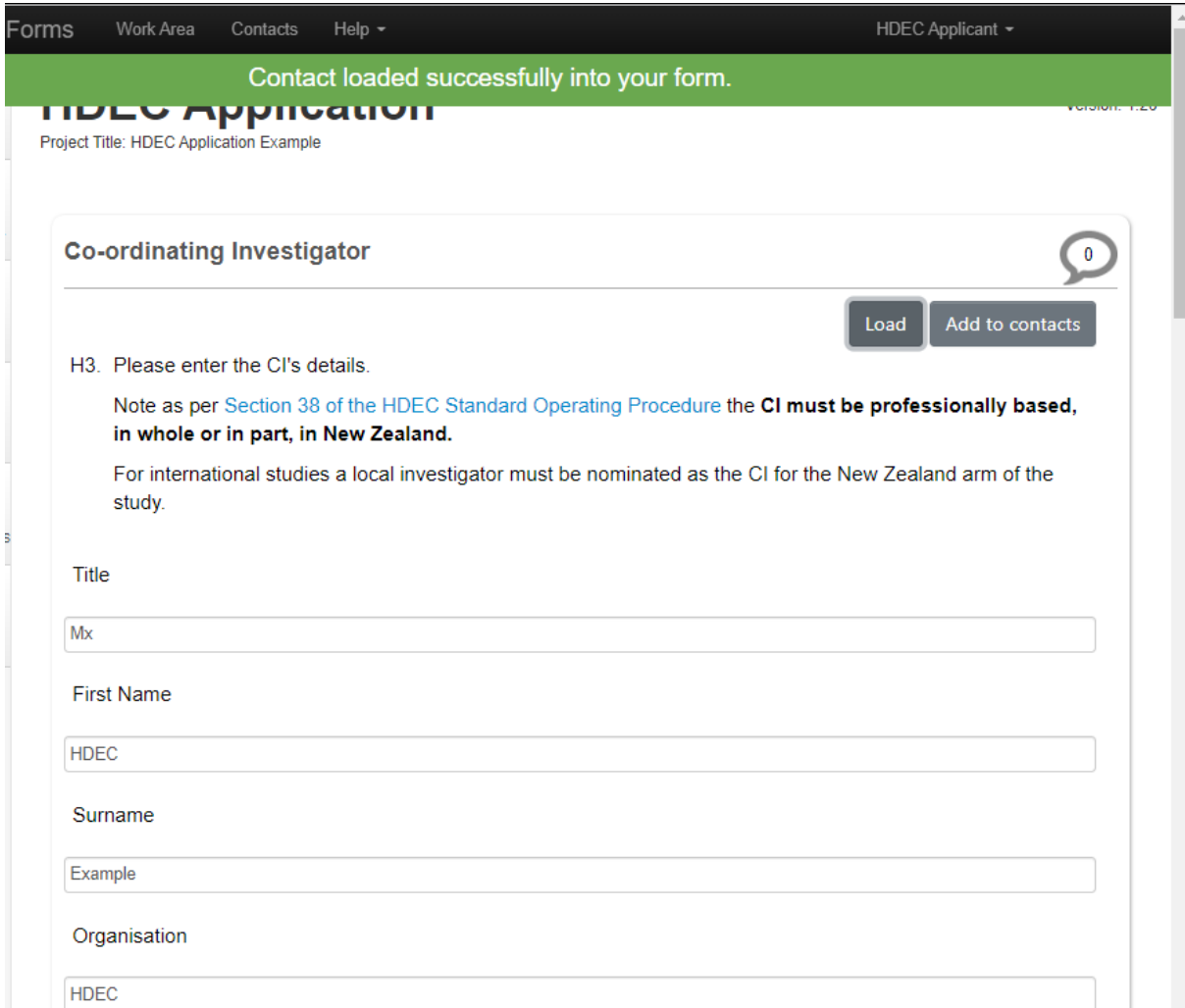
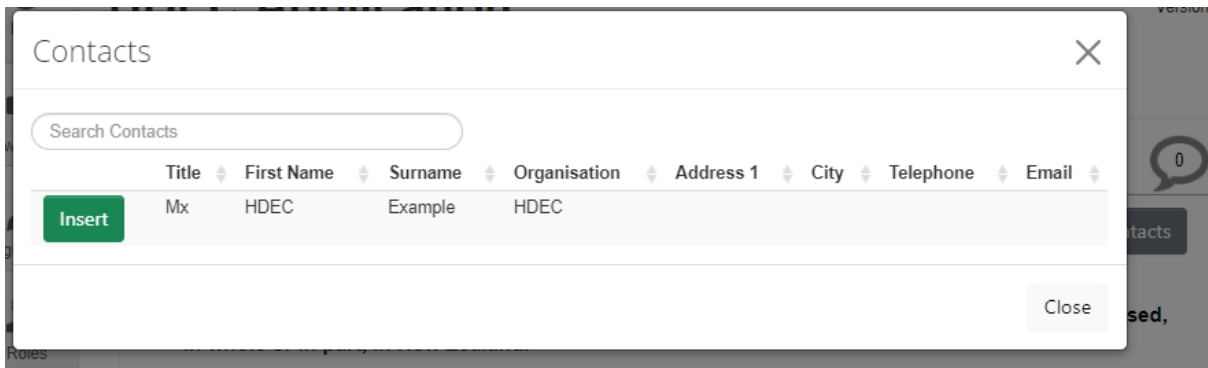

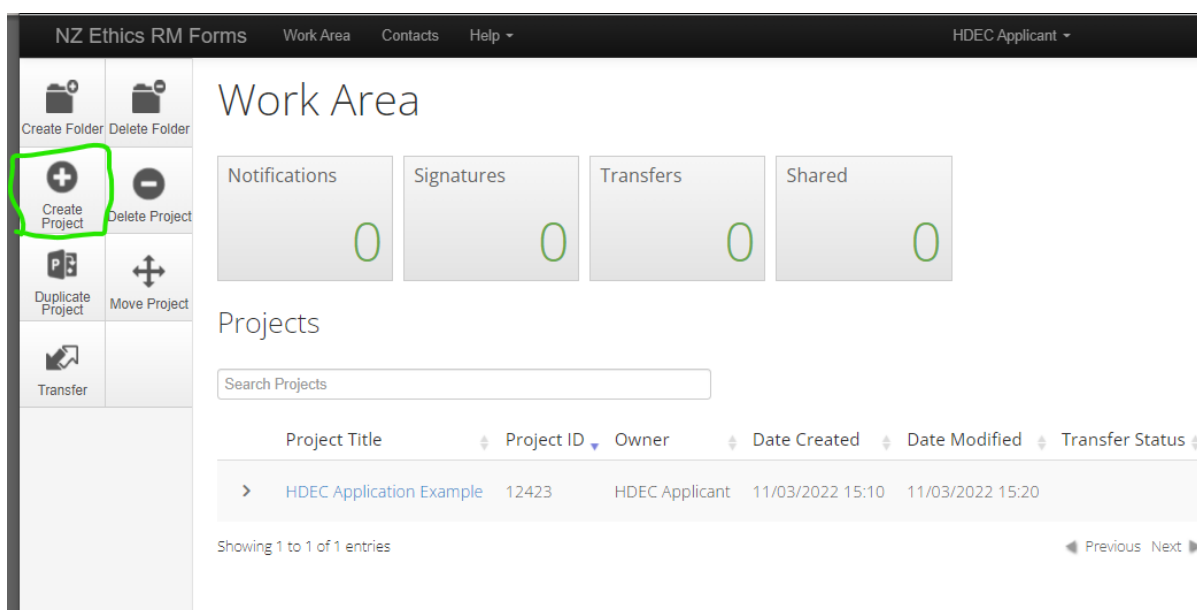
Alternatively, if you enter the details manually on the form, they can be saved by using the 'Add to contacts' button.

4. Create a new project

A project consists of:

- one main form (which can be an HDEC Application, Tissue Bank Application or a SCOTT Application)
- any number of post approval forms submitted after approval (sometimes referred to as 'Sub forms' within Ethics RM).

In the Work Area of Ethics RM, click the Create Project button on the left side.



Enter your Project Title and select which application you wish to make from the options under Form.

It is important to note that Project Titles **cannot** be amended once created.

Please ensure that you name the project as you wish it to appear in Ethics RM. In some circumstances a project may have a title, and a full formal title. If relevant, the full formal title of the study may be entered on the application form but is not required for all studies to be different from the project title. The full formal title is what displays on HDEC letters.

Click Create when you have finalised your project title and have the correct form selected.

History tab – selecting this tab shows the full history of the submission, including actions and decisions by both the project owner and the Secretariat. See page 31 for more information on the History tab.

5. Complete the form

The 'Navigation' tab is available on all forms (HDEC, SCOTT, Tissue Bank and Post Approval Sub forms). It allows you to navigate through the form by Questions under each Section. Inactive questions are not displayed unless you tick Show Inactive Sections. Active questions automatically display, clicking on them will take you directly to that question in the form. Certain questions are activated or deactivated depending on your answers to the questions in the form, so not all pages of the form will be active, and it is important you answer everything accurately to generate all relevant questions.

The form does not need to be completed in one session as there is a save button you can click at any time.

Clicking 'Navigate' in the form brings you back to the project main screen.

For guidance on the HDEC form screening questions please refer to the Appendix (on page 50).

To fill out the form, click the first question available for you to fill out. From there, you can proceed with filling in the form. If there are multiple pages, you may click Previous or Next on the left-side menu, as well as Previous Page and Next Page at the bottom of each page.

Click Save on the left-side menu if you wish to Save your progress at any time and navigate out of the form. You may return to certain sections using the Navigation tab from the project main screen.

6. Check for Completeness

It is important to check for completeness before you submit to make sure you have answered all the questions in the form.

While in the form or selecting the submission in the project tree in the main page of the project, click Completeness Check from the menu on the left of the screen to identify missing information from your application. Any outstanding items will be listed. You can select the highlighted questions to go to that section to complete them. Any sections that require signatures will also show up as incomplete if they are not yet signed.

You have the option to submit anyway, but we do not recommend this as a form is considered incomplete and will not be validated if it is missing sections. This will cause delays for your submission.

Once the application is complete, the check for completeness will say 'Your form is complete and ready to submit'.

7. Requesting a Signature and signing a form

What is a Signature?

Electronic signatures replace an 'ink' signature as evidence of authorisation for the Coordinating Investigator (CI), Sponsor, and Locality on forms generated on the Ethics RM system. This avoids the need to take or post paper copies of forms to the various individuals who need to authorise the application forms.

The persons authorising the form must have an Ethics RM account.

You can view current and pending signatures under the Signatures tab in the project.

How to request a Signature

The application form will prompt you to request signatures at the end. Please ensure the form has been completed **before** any signatures are requested. Ethics RM locks the form when signatures are requested and changing answers will invalidate any pending requests or completed signatures. If this occurs the signatures will need to be re-obtained. If you have requested a signature in error, you can simply unlock the form using the Unlock button on the left-hand menu.

By default, the CI and Primary Contact Person signatures are required. If you are the CI or Primary Contact Person you may sign the form yourself by clicking the 'sign' button, otherwise click 'request'.

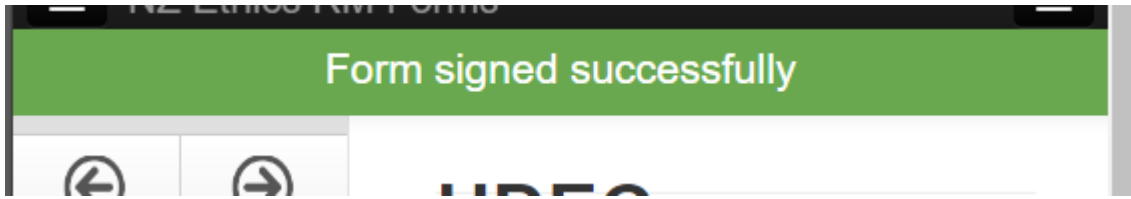

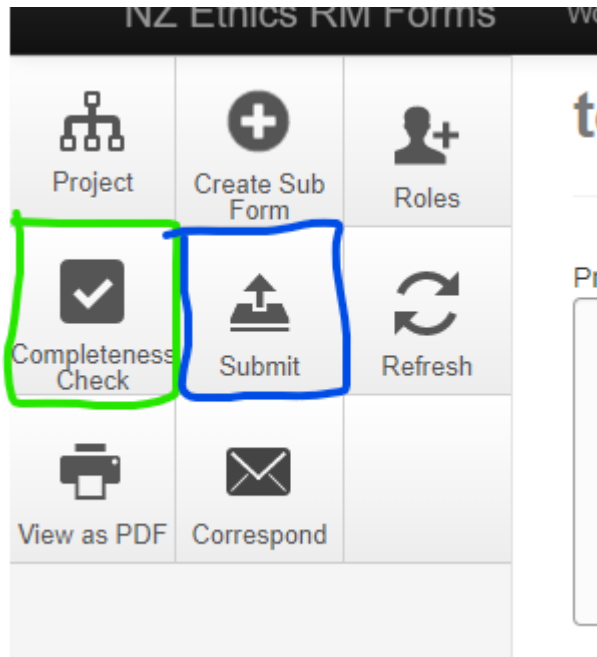
Signature validity

Signatures only need to be obtained once. If the form is submitted and invalidated or unlocked as part of a provisional approval, Ethics RM creates an archived version of the form in its current state and then unlocks a new copy of it for editing. The signatures on this copy will be invalidated but **do not** need to be re-obtained in order to submit and the original signatures preserved on the archived original submission are still valid for HDEC's purposes. Please note, the signatory process is likely to be revised in a future software update, but this requires working with our software vendor.

8. Submit a form

Once you have completed the form, uploaded the relevant documents and obtained all mandatory signatures, you can submit your application to HDEC or SCOTT.

You can do this by either clicking Submit after doing a completeness check, or by clicking the Submit button on the left-side menu.



Once you have submitted your form, you will be taken to a confirmation screen that confirms your submission as complete.

What happens next?

If your study is out of scope for HDEC review, you will receive an automatically generated out of scope letter.

Please note that this does not mean that your study has HDEC approval or that it does not require ethics approval - only that it does not require HDEC approval.

If your study is within scope for HDEC review, the HDEC Secretariat will assess your application and, if valid, assign it to either the full or expedited review pathway.

If your study requires full Committee review, you will receive a letter from the HDEC Secretariat providing the time and date of the Zoom meeting at which your application will be reviewed by HDEC. Study investigators are encouraged to attend these meetings.

If your study can be reviewed via the expedited review pathway, your application will be reviewed online by two HDEC members rather than in a full Committee meeting. Study investigators will not be present for this review.

If your study is not validated, you will be asked to update the information in your application before it can be assigned to a review pathway.

9. Frequently asked questions about submissions

Can I change my form after submitting?

No, you may not make changes to an application between submission and approval; however, you may recall or withdraw your study if you would like to make substantial amendments to your application.

I submitted my form then realised some documents are missing, how can I add them?

No documents can be added or amended after submission.

The form will need to be recalled (or withdrawn if it has been validated by the HDEC Secretariat). This can be done with the 'recall' button that will appear on the action menu after submission. To withdraw, please send a correspondence under the submission requesting a withdrawal, outlining the reason why.

The HDEC Secretariat **cannot add additional documents or amend approval letters** for studies that have been validated and assigned for review.

Which HDEC committee has my application been submitted to?

New HDEC applications submitted for review have the option to be reviewed 'as soon as possible' or by a specific committee. Please indicate your preference in the application form. If you select a specific HDEC committee, the form will ask for a reason (eg, resubmission of a previously declined study the HDEC committee is familiar with).

'As soon as possible' will be assigned to the next available HDEC committee meeting with a pending agenda and an available timeslot.

Those that requested a specific committee will be assigned by the secretariat to the HDEC committee requested.


10. Allocate Roles/set up permissions and set up email notifications for a project

What are Roles?

Roles are a function where you can extend this access and add collaborators to your project and grant various permissions.

By default, only the **project owner** has ownership and permission to view and edit the project.

To add a Role to this project, click the Roles button on the left side of the window. Enter the email of the person you wish to invite to see this project under Collaborator email. This person must have a registered Ethics RM account. Select what access you wish to grant and click the green + sign to add the role. Repeat this as many times as you require, and you can assign multiple roles to a single user.

12. Follow the progress of my submission and view letters from HDECs/SCOTT



13. Recall an application submitted for HDEC review



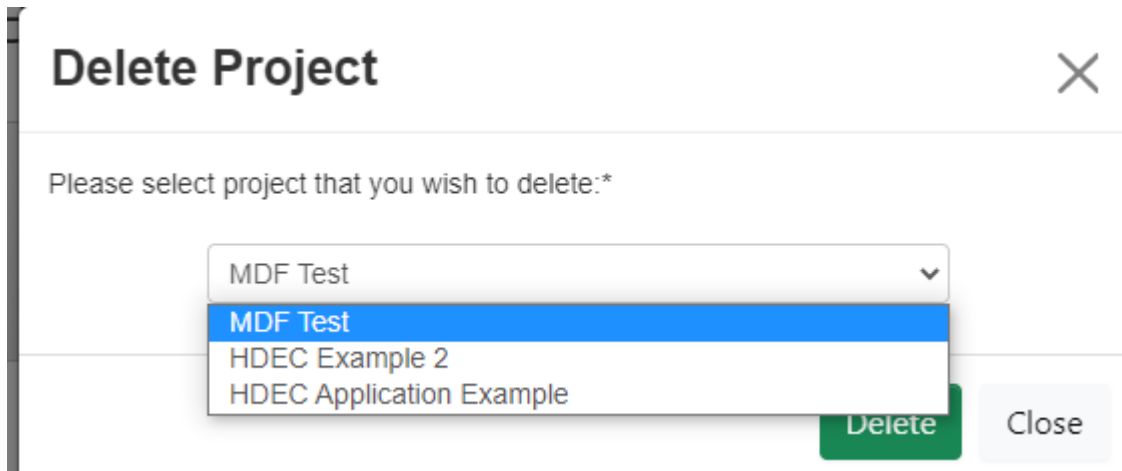

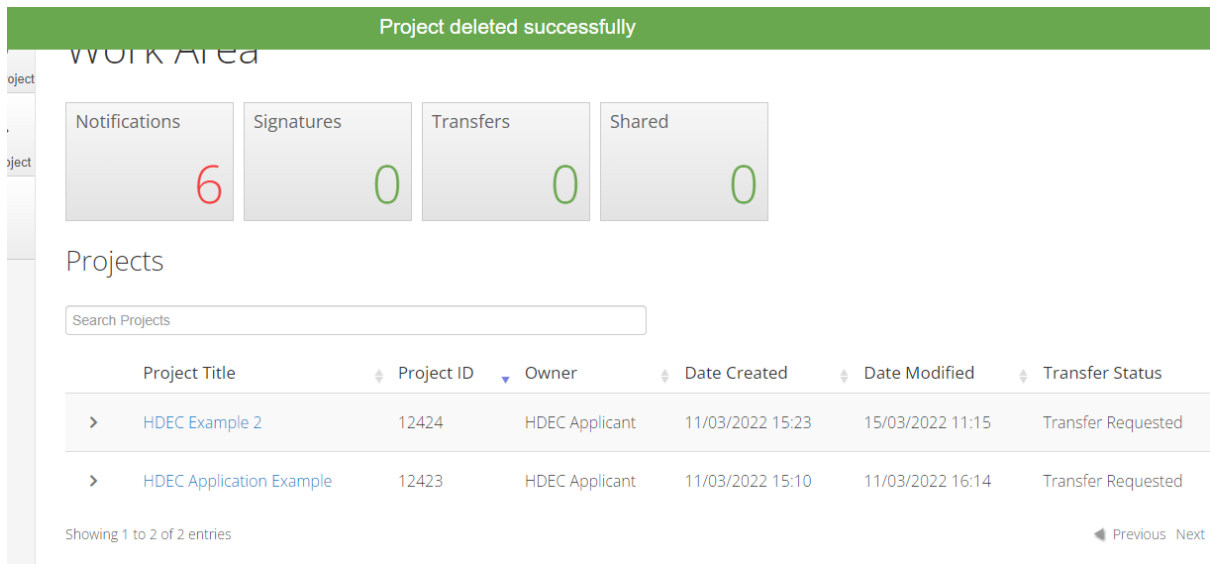

15. Manage Projects in the Work Area


This section lists all the available categories you can store your projects in. This is similar to directories in a computer filing system.

In addition to Create Projects, Delete Project, Duplicate Project and Transfer, there are other options for your Work Area to manage or sort your projects.

Users can create folders by clicking Create Folder to sort their projects into categories or even archive old projects if they wish.

These are user-customisable folders that may be named anything. Delete folder will delete a folder.

Move Project allows you to move projects into folders, however they may also be 'dragged and dropped'.

16. Create and submit a Post Approval Form

What is a Post Approval Item?

A 'post approval item' is an item submitted for HDEC review after a study has been approved. In Ethics RM post approval items are labelled 'sub forms' and are attached to their 'parent form' (the initial HDEC/SCOTT application).

Examples of post approval items include:

- substantial amendments
- annual progress reports
- protocol deviations or violations
- notifications of conclusion of study
- final reports.

Substantial vs Minor Amendments

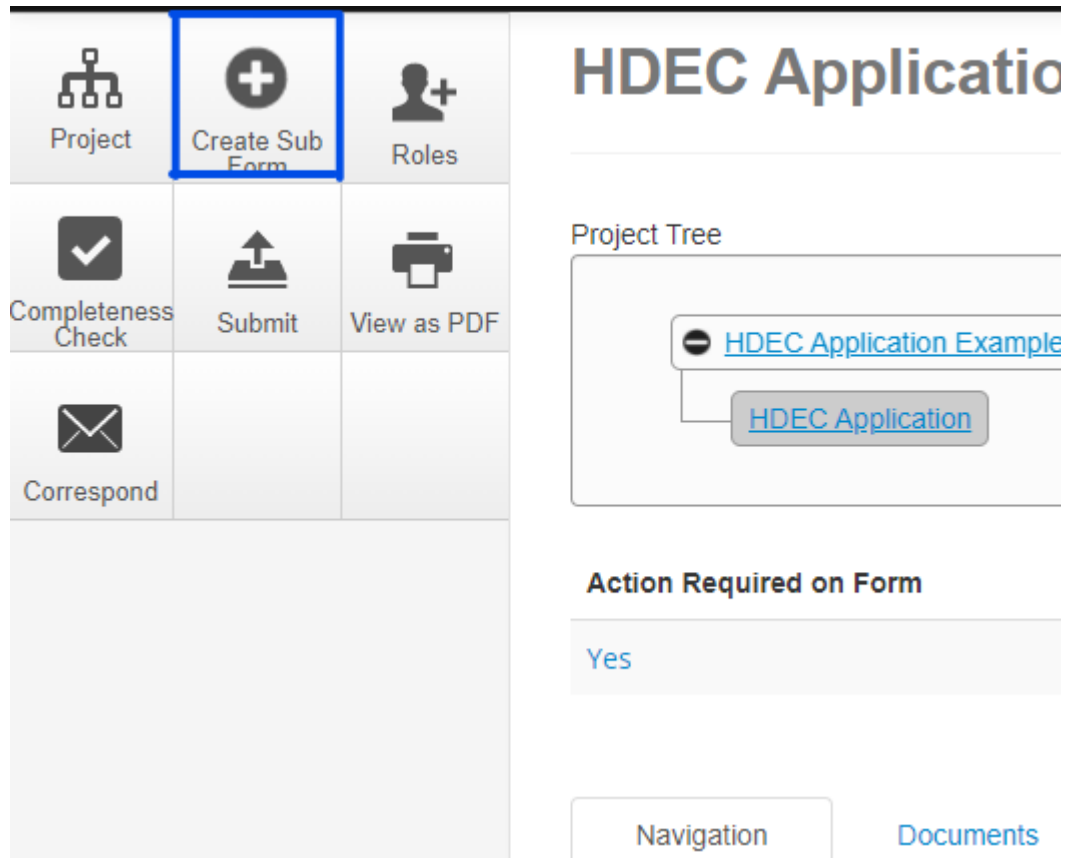
As per the [HDEC SOPs](#), an amendment to an approved study only requires HDEC review if it is substantial. Applicants may make minor amendments to an approved study at any time without approval from or notification to the HDEC.

SUBSTANTIAL AMENDMENTS	MINOR AMENDMENTS
<p>Significant amendments are required to be submitted for HDEC review. Examples of these include:</p> <ul style="list-style-type: none">- Significant changes to the design/methodology of the study.- Significant changes to the type and/or number of procedures undertaken by participants.- Changes relating to the safety of physical or mental integrity of participants, or to the risk/benefit assessment for the study.- Significant changes to study documentation (such as participant information sheets).- The appointment of a new CI.- Any significant change to the study protocol or the information provided in the application for approval.- Notification of urgent safety measures taken to protect participants from a significant, immediate hazard to their health and safety.- Temporary halts to the study due to safety concerns.- Substantial protocol deviations. - Early termination of a study.	<p>Minor amendments are not required to be submitted for HDEC review. Examples of these include:</p> <ul style="list-style-type: none">- Minor or administrative changes to study documentation.- Updated versions of the Investigator's Brochure (where the study involves a new medicine).- Changes to the research team (including lead/principal investigators at particular localities) other than the appointment of a new Co-ordinating Investigator.- Changes in funding arrangements, except where these may alter the ability of participants to access publicly-funded compensation in the event of injury.- Changes in arrangements for recording or analysing study data, or for storing or transporting samples.- The extension of the study beyond the expected end date given in the application form, except where this is related to other changes that are substantial.- Routine closure of a site.- Addition of a new site.

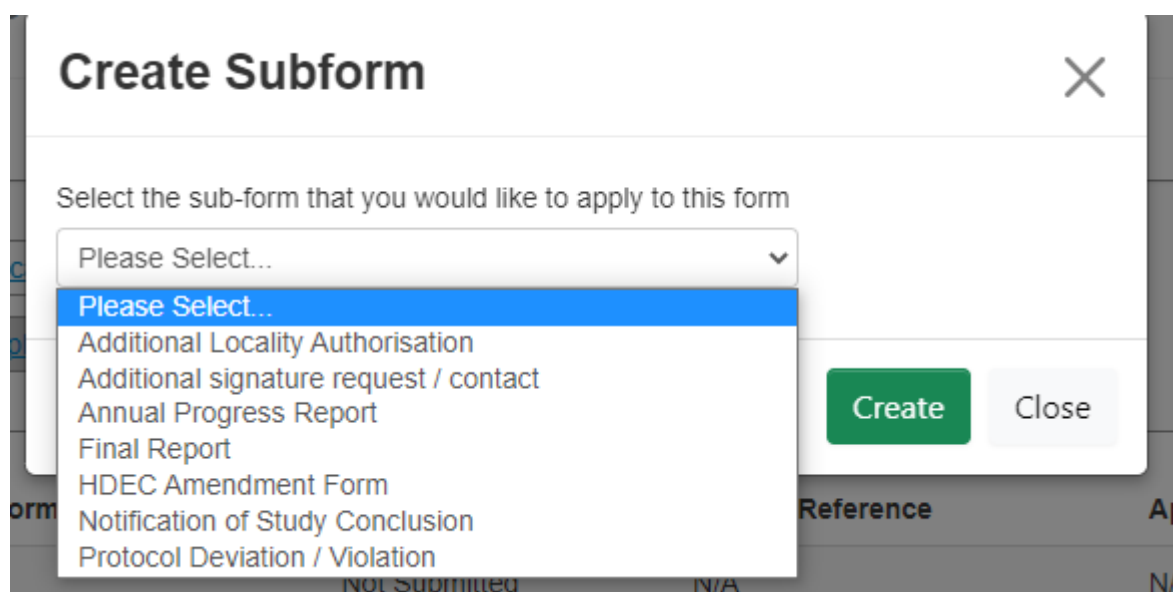
How to create and submit a Post Approval Form

Select the project from your Work Area you wish to make a Post Approval Form for. Only the project owner or those with 'Full Write' access can create and submit a Post Approval Form.

Once in the project, click the Create Sub Form button on the left-side of the window.



Select which kind of form you require from the drop-down menu.



Click Create.

Your Post Approval Form will now show up in the project tree under the application. Like applications, Post Approval Forms can be saved and completed at a later time by clicking the Save button before navigating away.

17. Manage or add a locality

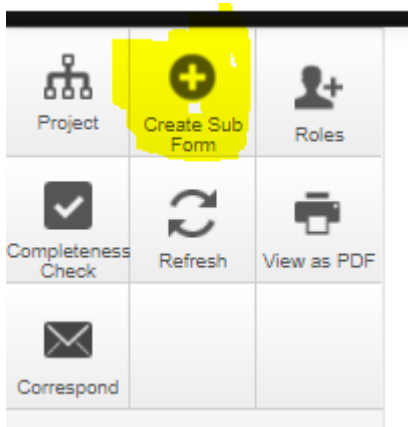
Before a study commences at a given locality in New Zealand, it must be authorised by that locality in Ethics RM. Locality authorisation confirms that the locality is suitable for the safe and effective conduct of the study, and that local research governance issues have been addressed.

Locality authorisations are not mandatory prior to submission – you may add a new locality at any time. You do not need to submit a Post Approval Form for HDEC review advising HDECs of the addition of a new locality. If locality approval has been obtained before submitting to HDEC, there is an option in the application form for the locality to sign.

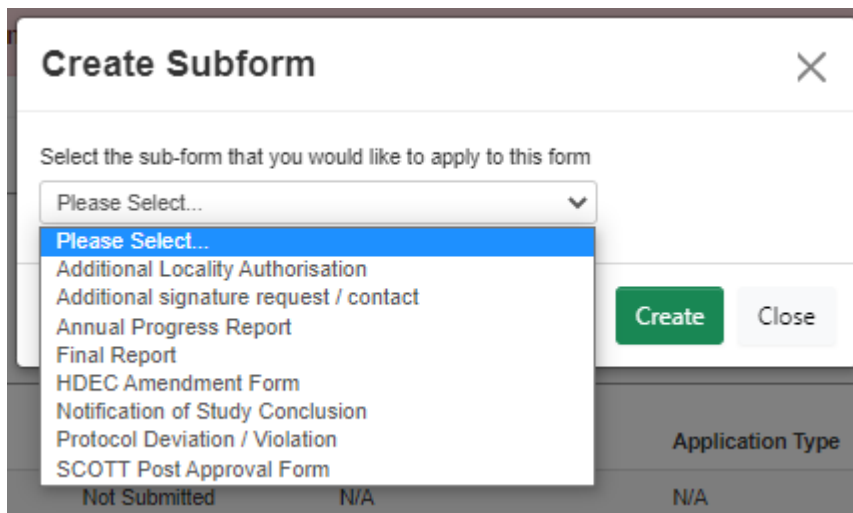
Additions of localities can be viewed in the project tree along with other Sub Forms such as Post Approval Forms.

Add locality after HDEC approval

To do this click on the study that requires an additional signature and then select the 'Create Sub Form' button.



Select the appropriate Sub Form depending on the signature requested (locality or individual investigator/sponsor representative) and click create.



The Sub Form has been created and will be attached to the application.

Please note: You will need to go onto the **main study form** and use the **Roles** button to grant at least read-access to the person you sent the request to. Failure to complete this step will mean they will only be able to view the Sub Form and not the main application itself.

18. Changing Co-Ordinating Investigator details

Co-Ordinating (CI) details may need to be updated during the course of the study. This can be due to the appointment of a new CI, or update information to the existing CI's details.

Appointment of new CI

Follow the instructions as outlined in section 16 on how to create a sub form. Appointment of a new CI is considered a substantial Amendment, so must be submitted for review using the Amendment form.

The last section of the Amendment form has a section where the CI details currently in use are auto filled. These must be amended to ensure the CI's details update for all future letters. If this was not done in error during the submission of the Amendment to notify change of CI, the details can be updated after the approval of the Amendment using the Change study details sub form (see below under Change CI's details).

Change CI's details

Changing the existing CI's details can be done by creating a Change study details sub form and editing the relevant CI fields you wish to change, then click Submit. See Chapter 19 (next page) for more information.

Overview

This form will allow you to change details of existing studies. This form will be automatically accepted by the system and NOT sent for review.

Please note changing the Coordinating Investigator is a substantial amendment that ALWAYS requires HDEC approval. Please do not change the Coordinating Investigator details unless this has been approved in a separate amendment.

19. Change of Study Details form

This sub-form allows you to change some of the details that display in HDEC letters as well as contact details for local and global sponsors.

These forms are not reviewed by the HDEC team and will be automatically accepted by the system.

Current details from the main submission will be displayed on the form and may be edited.

Change of Coordinating Investigator

This section will allow you to change details of the Coordinating Investigator (CI) in the system to ensure correct details are displayed in HDEC letters. **Please note that changing the CI to another individual is a substantial amendment that always requires HDEC approval.** If you need to change the CI please submit an amendment form instead and include the new CI details with that submission.

Please only submit changes to this section if:

- You have previously submitted an amendment to change the CI but did not update the details in that submission. They may be updated here.
- The current CI has a change of name or title and you want it updated for future letters. Once accepted by the system all future letters will display the new details.

If your study was created on the EthicsRM platform

- Please change the details in the "H3" question and leave the "MDF.CI" question blank.

If your study was created on the Online Forms platform and migrated to EthicsRM.

- Please change details in the "MDF.CI" question and leave the H3 question blank.

Entering details into both questions will cause a duplication of names in HDEC letters. Please ensure only one question has the CI details.

Change of study title

Entering details into both questions will cause a duplication of the study title in HDEC letters. Please ensure only one question has the CI details.

Change of locality / local study sponsor

This section allows you to change details of the local sponsor included on the main application form.

If your study was created on the EthicsRM platform

- Please change any details in the "H5" question and leave the "MDF.Sponsor" question blank.

If your study was created on the Online Forms platform and migrated to EthicsRM.

Change of global study sponsor

This section allows you to change details of the global sponsor in the EthicsRM form.

If your study was created on the EthicsRM platform

20. Submit a Response to Request for Further Information (Provisional Approval)

Submissions that receive a Provisional Approval decision from the HDECs must submit a response within 90 days to the request for further information, as outlined in the decision letter.

When a submission receives a Provisional Approval decision, the form submitted becomes unlocked and is now able to be edited by you. This will 'invalidate' any signatures on the form, but sponsor and locality signatures do not need to be obtained again. The coordinating investigator and applicant will need to re-sign the response.

Tracked change versions of documents are required when responding to further requests so the HDECs can view what changes have been made. Nothing in the original submission should be changed, and this response is considered in addition to the originally submitted documents. It is encouraged that a cover letter be submitted outlining all the changes requested and your response.

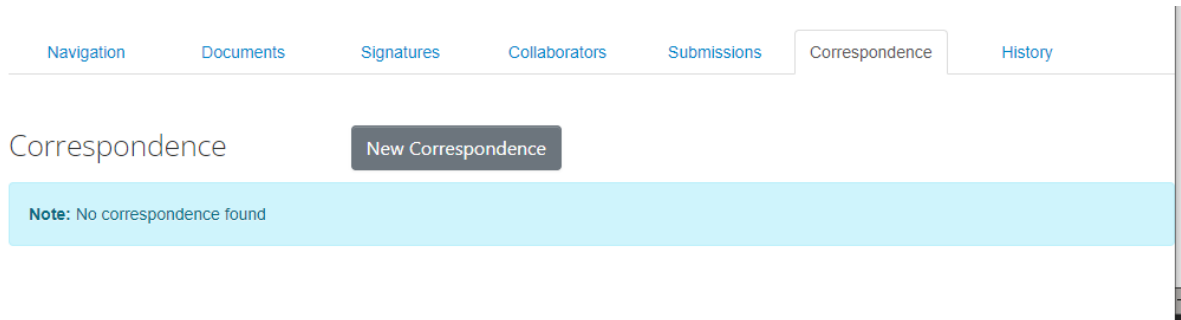

Note: Unlike the application form, Post Approval forms do not have a dedicated section for responding to requests for further information. The document upload section of the Post Approval form is appropriate to upload your response. The documents already uploaded should not be deleted.

21. Sending and receiving correspondences

Correspondence in Ethics RM is useful for contacting the Secretariat about the particular submission you are sending the correspondence from, especially if your query or issue cannot be answered in the FAQ on the HDEC website or contained at the end of this manual, or the wider documents available such as the Standard Operating Procedures or National Ethical Standards.

Correspondences can be accessed by selecting the Correspondence tab in a submission. Message history (both received and sent) will display here with timestamps.



You can send a new correspondence by selecting the New Correspondence button. You can also send correspondence using the 'Correspond' button on the left-hand side of the window.

If you receive a new correspondence from the Secretariat, this shows up in the Notifications tile in your Work Area, as well as a red alert in the Correspondence tab in the submission.

Documents can be attached to correspondence; however the Committee cannot review or approve anything sent via correspondence and will not be regarded as a post-approval submission.

Please do not submit additional documents that were not included with your application. If something has been missed, please recall the application, or contact the HDEC Secretariat to return the form to you.

22. Contact someone for help/support

Please see our [General](#) (on our website) and Ethics RM frequently asked questions (page 53) first to see whether your query can be answered. The Secretariat cannot provide technical support for all account or login issues but can help with HDEC-related queries and any issues with the forms or escalate to technical support if needed. 23. Manage my migrated project from Online Forms

This section relates only to applications submitted prior to September 2021 via the old Online Forms site.

My study was not migrated over, how do I find it?

If your study does not appear when you log on, please contact the project owner and ask to be added to the project as a collaborator. If you are unsure who the project owner is or believe it is yourself and the study is not showing, please email ethicsrm@health.govt.nz with the study title or reference and the Secretariat will identify the project owner.

Can I create post approval forms for my migrated study?

Yes. All migrated studies are compatible with the new post approval forms. Please see the standard guidance on creating post approval forms on page 40. You will see red text displayed at the top that states 'form is obsolete and cannot be submitted'. This is a message regarding the read-only status of your original application due to the data migration and does not prevent you from creating and submitting any post approval forms.

My migrated study was declined, how do I reapply?

As the HDECs introduced the new application form with the launch of ERM on 1 September 2021, the old forms are unfortunately incompatible and unable to be duplicated. You will need to create a new application. Although many of the questions have changed and new questions have been introduced to align with the [2019 National Ethical Standards](#) many of the answers can be copied and pasted onto the new form.

How do I find signatures/authorisations from the old system?

Any signatures given on a project have been attached to the application's migration form. To find these click on the study from the main work area, scroll down to the navigation area and click on the 'Authorisation Report' tab.

How do I submit a response to provisional approval for my migrated study?

Any submission that was provisionally approved at the time of migration is now since overdue and would have been withdrawn. A new submission would be required in this instance.

Appendix

24. Filling out the HDEC Application Form

Completing the screening questions of the first two pages of the HDEC form will activate more of the form if your project is determined to be in scope for HDEC review. You must read and agree to the Disclaimer to display the scope/pathway of your project and proceed with the rest of the form or out of scope acknowledgement.

Please ensure you have read the [HDEC Standard Operating Procedures](#) and [National Ethical Standards](#) before applying to HDEC for review if your study is in scope.

Full vs Expedited HDEC Review

The one HDEC form is used for all applications, regardless of review type (full/expedited). The answers you provide in the screening questions will determine whether the application will be reviewed via the full or expedited pathway.

An application assigned to the full review pathway is reviewed at an HDEC committee meeting. The committee has 35 calendar days from the close of agenda to review the application and make a final decision. This timeframe may be suspended once for up to 90 calendar days when the committee requires additional information in order to make a final decision.

An application assigned to the expedited review pathway is reviewed by a subcommittee comprised of the Chair and up to two other members. This does not involve a physical meeting of the committee. A final decision must be made within 15 calendar days. This timeframe may be suspended once for up to 90 calendar days when additional information is required in order to make a final decision.

To proceed with either of these pathways, click the Proceed option then click Next Page.

My application is out of scope

If, after answering the screening questions, you are confident that your study does not require an HDEC review based on answers input in the screening questionnaire, then please approach the research office at your university or DHB to discuss your study and the internal ethical review process.

If you require formal acknowledgement that, based on your answers, your project is out of scope for HDEC review, please click Proceed then click Next Page. An automated email will be sent immediately to the project owner confirming that the project is out of scope based on the answers of the screening questionnaire.

Please note that if you indicate your project is not health and disability research, you will not be able to receive an acknowledgement as HDEC only reviews health and disability research. The acknowledgement is reserved for projects that may require proof it is out of scope due to uncertainty.

If more than one or no review pathway displays

Only one pathway should display at the end of the screening form. Occasionally a combination of answers in the screening form may trigger an incorrect response and two or zero pathways will appear. If this occurs, please export the application as a PDF (using the 'view as PDF' button on the action menu to the left) and email it to ethicsrm@health.govt.nz. An HDEC advisor will contact you and advise which pathway to proceed with.

The HDEC Secretariat will ensure the combination is included in the next update to the screening algorithm so future studies will go via the correct pathway.

25. Frequently Asked Questions (FAQ)

General HDEC FAQ

The HDECs have a [general FAQ](#) available on their website that is updated periodically.

What web browsers are okay to use with EthicsRM?

- Chrome and Firefox are supported browsers for Ethics RM.
- Issues have been reported when using Internet Explorer or Safari with Ethics RM.

Are there any other extra resources to help me with Ethics RM?

- We do have two initial videos available:
 - <https://youtu.be/0QdYTCioDUo>(external link) - step-by-step guidance on account creation and login, creating, submitting, recalling applications and the main work area screen
 - <https://youtu.be/SxxOQVz0HMk>(external link) - step-by-step guidance on sharing, transferring form to colleagues and system 'roles', creating post approval items and existing applications from Online Forms.

I accidentally put the wrong version/date on a document. Can I change the version/date of the document after I have submitted it?

- You will need to immediately recall your submission before it is validated to correct your submission.
- If validated, you will need to contact the HDEC's Secretariat immediately (either through hdec@health.govt.nz or via the ETHICS RM 'Correspondence' tab for the study) and advise us of your mistake. This can only be updated prior to a decision letter being sent.
- We will not be able to update any letter sent before this notification.

The HDEC letter has the wrong version number/date. Can you amend this and resend the letter?

- As the list of documents submitted in the letter has always been automatically generated based on what you have submitted, we are no longer editing these in ETHICS RM. However, if a letter is incorrect because of either an ETHICS RM error or an HDEC error, we can amend those.

Can I change the title of my study?

- Unfortunately, a project title in Ethics RM is unable to be changed once it has been created.
- The title may be changed on all future letters only by changing the field where the title generates in the Amendment sub form, or by creating and submitting a 'Change of study details' sub form.

What happened to the old references used before Ethics RM?

- The format for references used prior to our transition to Ethics RM is no longer available to us and is currently not something we can change. We apologise for any inconvenience this may cause as some studies may not have clear submission references as previously used.

The 'Submit' button is not showing up for me in my Post Approval Form, how can I submit?

- Check the 'Collaborators' tab and ensure that you have full permission to submit forms. If the project owner has enabled you for limited access only (e.g., you can view

or edit the form but not submit it) they will need to revise your permissions using the 'Roles' button to grant full access or submit the form themselves.

- If you have permission to submit, you may need to check whether the form needs to be updated first. You will be prompted to do so if this is the case with a red or yellow banner stating this.

What does it mean if it says my 'form is obsolete and cannot be submitted'?

- The system will display this message for applications that were migrated from the old Online Forms website. This only refers to the migrated form itself – not the application as a whole.
- Post approval forms can still be created by selecting the 'Create Sub Form' action and will attach to the migrated application.

I have been asked to update the form before I have submitted it, will this remove anything I have put in so far?

- When a new version of the form is published the system since your form was first created, it will prompt you to update it. All data entered on the form will be preserved unless the question itself has been replaced. The update notes will list any significant changes.
- You can check whether your answers have been removed by clicking 'Check for Completeness'.

I have a study that was submitted before Ethics RM was introduced and I need to find evidence that the study was authorised. Where can I find this?

- You can find this by checking the metadata of the MDF form by clicking the 'Navigation' tab, then 'Authorisation Report'.

I submitted my response to a provisional approval or had my application invalidated and now I have two versions of my study!

- When a new version of a form is submitted the previous version is archived and kept on record. Previous versions can be found under the 'Submissions' tab for the study.

I have been requested to sign a form but it says it is locked, what does this mean?

- Signing a form should still be possible. Note if you have received a request from a sub form the signature can only be signed on the sub form itself (and is valid for the study it is attached to).

My signature is 'invalidated' what does that mean?

- Any change to the form will invalidate any active signatures. Please note this includes when the HDEC publishes updates. If the signature has been invalidated, it will need to be requested and signed again. Please ensure no changes are made to the form after a request is sent.

Can I upload multiple documents at once?

- This is currently not a supported feature of ERM. The HDEC Secretariat has requested the developer include this feature in future update.

My letter has an error! Can this be corrected?

- If your letter contains an error caused by the HDEC Secretariat it can be reissued. Please use the 'Correspondence' button to send a message through Ethics RM advising of the error and a team member will be in touch.
- If it is a result of researcher error (e.g., the wrong version number or date on a document) this cannot be changed as it was the document identifier received by the HDEC at the time of review. Please ensure these are correct before submitting.

I did not receive my out of scope letter

- As this is sent via an automated email immediately following submission of an out of scope pathway application form, users may find this email in their spam or junk folder in their inbox from a no-reply address.
- If you are still unable to find it, you can email the Secretariat or send a message via Ethics RM and outline that you have been unable to find it in any of those folders and request a version they can provide to you.
